MOODS OF NORTH-EAST

The dance presentation by "Antara Kala Kendra" from Nagaon, Assam at Netaji Subhash Hall on Saturday 2nd May 2015 was of a different note. Mandira Bhattacharya who led a team of 20 Tribal Artists from a remote village in Assam rightly deserved high appreciation from the packed audience. RABINDRA JAYANTI

The open stage on the back lawn with its green ambience attempted to give a colour of Shantiniketan where the birthday of Kavi Guru Rabindra Nath Tagore is celebrated in a traditional way.

Hence right in the morning, the band of workers from Tent House, Thermocol Artist, Electrician and KMS officials were all in the open lawn in front of Kali Temple to complete the preparations of the celebration scheduled in the evening. 80 strong Artists attired in their best Bengali traditional dresses from five well-known Rabindra Sangeet Institutions of the Capital adorned the stage with their mentors and mesmerised the overflowing audience by their 1½ hour non-stop capsuled Rabindra Sangeet and Recitation programme. Special attraction in the evening was the recitation presentation by Bishaka Mukhopadhyay from Kolkata. It was an enjoyable evening to the delight of the audience.
